

Two Months FY24 Cumulative Operations Budget Execution









Completion of FOC Oversight and Verification



Initial 5-year Radio Access Network (RAN) buildout and State Commitments have now been verified complete by the FirstNet Authority

- 100% Rural and Non-Rural Band 14 Coverage Contract Milestones
 - Approximately 1.9M Square Miles of Band 14 Coverage in place
- Opt-In Commitments for all 56 States and Territories delivered – examples include:
 - Coverage: New Site Builds and Band 14 spectrum adds
 - Temporary Coverage: Deployable assets and additional form factors
 - Pacific Territories unique requirements
 - Cybersecurity requirements
 - Device Connection Targets




