**GOVERNANCE AND PERSONNEL COMMITTEE RESOLUTION 10**  
REVISION OF THE PUBLIC SAFETY ADVISORY COMMITTEE CHARTER  
December 13, 2018

WHEREAS, the First Responder Network Authority (FirstNet Authority) was established under the Middle Class Tax Relief and Job Creation Act of 2012 (Act), which mandates the creation of a nationwide public safety broadband network that will enable police, firefighters, emergency medical service professionals, and other public safety officials to more effectively communicate and perform their missions;

WHEREAS, the Act requires the FirstNet Authority to establish a standing public safety advisory committee (PSAC) to assist in carrying out its duties and responsibilities;

WHEREAS, on September 25, 2012, the FirstNet Authority Board adopted Resolution 4 establishing the PSAC;

WHEREAS, on December 12, 2012, the FirstNet Authority Board adopted Resolution 13 defining the roles and responsibilities of the PSAC;

WHEREAS, on June 3, 2014, the FirstNet Authority Board adopted Resolution 59 approving the PSAC Charter;

WHEREAS, on June 29, 2016 the FirstNet Authority Board adopted Resolution 76 revising and amending the PSAC Charter;

WHEREAS, the FirstNet Authority desires to modify the PSAC Charter to designate the FirstNet Authority's Executive Director of Public Safety Advocacy as the FirstNet Authority liaison to communicate work assignments, priorities, and work plans to the PSAC on the FirstNet Authority's behalf, and to streamline language related to the scope of the PSAC's activities and operations;

NOW THEREFORE BE IT RESOLVED that the Governance and Personnel Committee approves and recommends that the Board adopt the revised and amended PSAC Charter as presented to the Board by FirstNet Authority senior leadership, copies of which are attached hereto as Exhibit A.

#### PUBLIC SAFETY ADVISORY COMMITTEE

(As Amended December 13, 2018)

#### 1. Committee's Official Designation (Title)

Public Safety Advisory Committee (PSAC)

#### 2. Authority

The First Responder Network Authority (FirstNet) established the Public Safety Advisory Committee under the authority of the Middle Class Tax Relief and Job Creation Act of 2012 (Tax Relief Act), Pub. L. No. 112-96, 126 Stat. 156, § 6205(a)(1) (47 U.S.C. § 1425(a)(1)), and in accordance with the Unfunded Mandates Reform Act, 2 U.S.C. § 1534(b).

#### 3. Objectives, Duties, and Scope of Activities

The PSAC provides advice and recommendations to FirstNet. The objective of the PSAC is to assist FirstNet in carrying out its duties relative to the design, construction, deployment, and operation of the nationwide interoperable public safety broadband network. The PSAC will assist FirstNet in maintaining the crucial dialogue and relationships with local, state, tribal, and federal government and public safety leaders.

The PSAC will also enable FirstNet to receive feedback from and exchange ideas with a wide swath of important stakeholders. Thus, the PSAC will support FirstNet in more effectively reaching its goals of ensuring the building of a nationwide public safety network and providing the best possible service to the public safety community. The scope of the PSAC's activities will be limited to matters involving shared intergovernmental responsibilities or administration related to public safety communications.

FirstNet seeks the advice of the PSAC on a wide variety of matters involving shared intergovernmental responsibilities or administration related to public safety communications, including, without limitation, advice on aspects of public safety stakeholder engagement, and network operation, services, and use. FirstNet will issue written requests for these and other matters in the order FirstNet deems most helpful in consultation with the PSAC, and the PSAC will provide advice and recommendations to FirstNet in response to such requests. The PSAC may request additional assignments or modification of assignments, where appropriate. The PSAC will assist FirstNet by representing the consensus views of the public safety community to FirstNet, where feasible. It may also provide a forum for public safety stakeholders to present current and emerging issues in public safety network management, policy, reform, and technology.

#### 4. Designated FirstNet Point of Contact and Support

The PSAC provides advice and reports to FirstNet's Executive Director of Public Safety Advocacy (PSA), who serves as the Designated FirstNet Point of Contact (POC) to the PSAC. FirstNet will provide staff and resources to support the committee. The Designated POC will also communicate work assignments, priorities, and work plans to the PSAC on FirstNet's behalf.

#### 5. Estimated Number and Frequency of Meetings

It is anticipated that the PSAC will meet in person approximately two times a year, as determined by the PSAC Chair and subject to the call of the Designated FirstNet POC. The PSAC may hold additional meetings, whether in person or by other means, as determined by the PSAC Chair and subject to the call of the Designated FirstNet POC. FirstNet staff shall take the official notes of all meetings.

## 6. Membership and Designation

The PSAC shall be comprised of no more than 45 members who represent local, state, and tribal public safety organizations and shall also include a federal member from the U.S. Department of Homeland Security and the U.S. Department of Justice.

Non-federal members must be elected or designated officials of local, state, or tribal governments serving in their official capacities, which includes the Washington D.C. representatives of such organizations. A list of such organizations is set forth at appendix A. Such members shall be recommended by their respective organizations, but must be appointed by the Chair of the FirstNet Board. Non-federal members of such organizations will serve for a term of two years, but may be reappointed for additional consecutive terms. Federal members shall be recommended by their respective organizations, but must be appointed by the Chair of the FirstNet Board. Federal members will serve for a term of two years, but may be reappointed for additional consecutive terms.

The PSAC shall be headed by a Chair and an Executive Committee, consisting of five members (including the Chair) appointed by the Chair of the FirstNet Board. The PSAC Chair shall serve a one-year term, but may be reappointed for two additional consecutive terms. Subsequent appointments (beyond the three years) of the PSAC Chair may be approved by the FirstNet Board.

The Executive Committee shall assist the PSAC Chair in operating the PSAC and coordinating with the full PSAC membership. Each member of the Executive Committee shall serve a one-year term, but may be reappointed for additional consecutive terms. Decisions of the Executive Committee shall be by majority vote.

No member of the PSAC or its subgroups shall be a registered lobbyist under the Lobbying Disclosure Act of 1995, as amended, 2 U.S.C. § 1601 et seq., in accordance with the President's Memorandum on

Lobbyists, Memorandum for the Heads of Agency Boards and Commissions: Lobbyists on Agency Boards and Commissions (June 18, 2010), <http://www.whitehouse.gov/the-press-office/presidential-memorandum-lobbyists-agency-boards-and-commissions>.

#### 7. Subcommittees

FirstNet may create subcommittees, working groups, standing committees, ad hoc groups, task groups, or other subgroups as it considers necessary for the performance of the PSAC's functions. Like the full committee, PSAC subgroups may meet solely for the purpose of discussing shared intergovernmental responsibilities or administration related to public safety communications. Any subgroup established will report to the Executive Committee and must not provide advice or work products directly to FirstNet.

#### 8. Duration and Amendment

The PSAC is a standing committee. This charter will remain in effect until 2027 and may be amended from time to time by FirstNet.
