### ON MY MIND

It's hard to believe that just one year ago, we closed out "opt-in" season, with 56 U.S. states, territories and the District of Columbia opting in to FirstNet. When I reflect on what FirstNet and the First Responder Network Authority have accomplished in 2018, it makes me proud to serve the public safety community as part of FirstNet and enthusiastic for the year ahead. A few highlights of 2018 for me:

**Harry Markley** Since the launch of FirstNet service, 3,600 public safety agencies nationwide have chosen to improve communications for first responders by joining FirstNet -- and we expect that number to continue to grow in the coming months. Our app and device ecosystems continue to grow, with several dozen public safety apps in the [App Catalog](#), and more than [60 devices](#) reviewed and available for use on FirstNet.

Over the last year, first responders experienced FirstNet in action during large events like New Mexico's Albuquerque International Balloon Fiesta and the Boston Marathon. Events like these draw large crowds that cause network congestion, but FirstNet makes it possible for responders at these events to communicate seamlessly and securely.

In March, the First Responder Network Authority gave AT&T, our network contractor, the green light to expand FirstNet's footprint by making available Band 14, public safety's dedicated spectrum. With Band 14, FirstNet is giving first responders access to additional capacity and expanded nationwide coverage whenever and wherever they need it.

Also in March, we launched the FirstNet network Core -- the first-ever nationwide LTE enhanced packet core infrastructure built specifically for our nation's first responder community. The FirstNet Core is the brain and nervous system of the nationwide network, separating public safety traffic from commercial traffic and supporting current FirstNet functions, like Quality of Service (QoS), priority and preemption. It will also support future mission-critical services to be offered by FirstNet, like mission critical push-to-talk and location-based services.

In October, FirstNet subscribers gained access to a lending library of 72 dedicated deployable network assets. The deployables are stationed around the country to provide backup in disasters or for large events, and they are available within hours at no extra costs to public safety subscribers. Imagine the impact that can have in maintaining communications in hurricanes and wildfires, search and rescue missions, or containing gas leaks and explosions.

Also in October, I attended IACP's Annual Conference and Exposition in Orlando. Throughout the event, my colleagues and I had the opportunity to moderate and be a part of discussions that ranged from public safety's use of mobile data and devices to new applications that benefit the law enforcement community. IACP is always a wonderful occasion to hear from leaders and discuss changes and challenges from officers and how FirstNet can help fill those gaps. I am already looking forward to attending next year.

In my last email to you, we shared the news of the appointment of **Edward Horowitz** to FirstNet Board Chair. I had the opportunity to introduce him to the leadership of some of the major law enforcement organizations, including IACP, the National Organization of Black Law Enforcement Executives (NOBLE) and the National Sheriffs' Association (NSA). I look forward to introducing him to you through additional engagements in the new year.

2018 was a great year for FirstNet and for public safety. I wish you all a happy holiday season, and look forward to working with you next year.

- Received updates from the PSAC and AT&T

They discuss how drones will help provide better situational awareness to the law enforcement community and other public safety professionals -- especially for search and rescue and other missions.

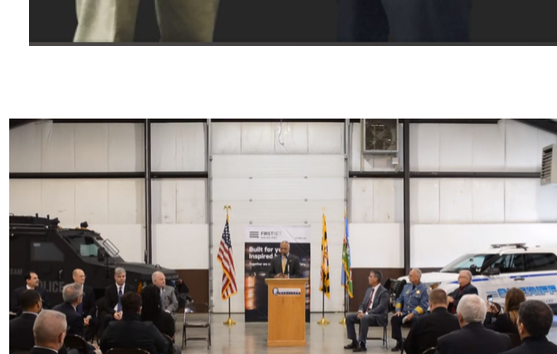

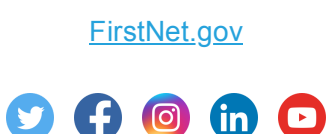
