- Hosted technology demonstrations from industry, academia, and public safety organizations
- Recognized distinguished leaders in public safety



- Attended the nation's premier event for the 9-1-1 profession and public safety communications officials
- Executed 12 sessions with AT&T and public safety leaders covering lessons learned from Butler, Pa., drone response during Hurricane Helene, and recent enhancements to FirstNet Central driven by investments
- Held fruitful discussions with association leadership and various stakeholders




Coverage Enhancement Workshops


